# School system to host nationally known artists for festival

Hoke County Schools will hold its annual All County Arts Festival Saturday, May 17 at Sandy Grove Middle School. The festival is the culmination of a week of emphasis on the arts that includes work by nationally known clinicians with students in the Hoke County School system. Featured will be an All County Art Show highlighting work by students grades k-12, a middle school and high school dance performance, a middle school and high school choir performance, a performance by high school theater arts students, performances by the Hoke High School Jazz Band, the Hoke High All County Ensemble and a per-

formance by a 100-piece middle school all county band. Activities begin Friday morning with all second graders being entertained by a storyteller in the Turlington Auditorium.

"We are extremely proud to have been able to bring such strong clinicians to work with our students," said Bob Barnes, assistant superintendent.

The storyteller for second grade students is Mitch Capel, "Gran'daddy Junebug." Capel, a master storyteller and recording artist, is nationally known, has been featured at the National Storytelling Festival, is a regular at the National Black Storytelling Festival and has been referred to as a "word magician" and a "national treasure."

Working with the chorus students will be Sharon McNair, a noted choral music instructor from Cumberland County. She is best known for her work as choral instructor for E.E. Smith High School and adjunct professor for Methodist University. She has performed in numerous productions at the Fort Bragg Playhouse, the Gilbert Theater and the Cape Fear Regional Theater.

Shelia Kerrigan, also known as "The Mime Who Talks," will be working with Theater Arts students. A published author who has

performed with the North Carolina Symphony and holds a black belt in karate, she has worked with the Durham Arts Council, the Arts Council of Fayetteville, The United Arts of Raleigh-Wake, the Arts & Sciences Council of Charlotte-Mecklenburg, and the South Carolina Arts Commission.

Katherine Hardison will direct the work with high school and middle school dance students. A dance instructor at South East Dance Academy, she holds a Carolina Dance Masters Certification and has frequently appeared at performances with the Opera House Theater Company. Some of her most notable performances include "Hairspray," "The King and I," "The Best Little Whorehouse in

Texas," and "A Chorus Line." Rounding out the list of clinicians is Dr. Julian White who will be working with instrumental

Funding for all clinicians was made possible through a grant from the North Carolina Arts In Communities, a division of the N.C. Department of Cultural Resources.



Tomatoes, relative to the potato, peppers, and eggplant, are the most popular garden vegetable in the United States. They can be grown using several different methods such as traditional farming, raised beds, containers, grow bags, greenhouses, and baskets. For many people, it's not planting the tomatoes that seems to be challenging, it's producing high quality fruit.

Much success in growing tomatoes can be attributed to use of a few proven techniques. Choosing a variety that has proven to be a true performer should be at the top of every gardener's list. Better Boy, Whopper, Celebrity, and Mountain Pride are among some of the best selections. Better Boy, Celebrity, and Whopper are VFN, which means they carry resistance to verticillium wilt, fusarium wilt, and root-knot nematodes. It is best to experiment with several varieties in order to find the ideal tomato for your taste buds.

Use the best soil available to grow the tomato crop. Clay and sandy soils can be improved by working in 2 to 3 inches of compost, peat moss, or other forms of organic matter in the top 6 to 9 inches of soil. Lime and fertilizer should be added according to soil test recommendations.



If no soil test has been taken, apply 3/4 cup of lime and 1/2 cup of 8-8-8 fertilizer for each plant. Lime will help reduce nutrient imbalances, particularly with calcium, and help control the blossom end rot problem that occurs so frequently on tomatoes.

Tomato plants should be spaced 1 1/2 to 2 feet apart in the row and 3 to 4 feet between rows. The planting hole should be deep enough to allow the top of a peat pot to be covered with one inch of soil. If the peat pot is exposed to the air, it will act like a wick and rapidly dry out the root ball, causing stunting or death of the plant.

If the transplant is tall and leggy at time of planting, the trench planting method should be used. To trench plant a tomato plant, dig a horizontal trench rather than a hole for each plant. Next, remove all of the leaves from the plant except the top leaf cluster (4 to 5 leaves). Then lay the plant on its side in the trench and cover the root system and bare stem up to the top leaf cluster with 2 to 3 inches

around the outside edge of the cage to give it extra support.

Side dress tomato plants with 2 to 3 tablespoons per plant of a complete fertilizer such as 8-8-8 or 10-10-10 after the plants have started to set fruit and 4 to 6 weeks thereafter throughout the growing season. Keep the side dressing material 4 to 6 inches from the plant's stem to avoid fertilizer burn.

It is important to make sure the tomatoes receive sufficient water during the season. The soil should be soaked 6 to 8 inches deep at 7-day intervals. Mulches such as wheat straw or composted leaves around the tomato plants will prove to be a real asset in conserving soil moisture during July and August.

Finally, have a prepared plan for dealing with the various insect and disease problems. Frequent observation of tomato plants for pest damage is the only way to stay ahead of the game. The Hoke County Cooperative Extension Center will be hosting a tomato workshop on May 15, 2014 at 6 p.m. The cost of the workshop is \$5 and will cover planting and insect and disease management of tomatoes. of soil. Firm the soil over the plant. Be sure not to press the soil too firmly around the stem where it comes out of the soil, as the stem may break.

A starter solution should be used at planting time to ensure



the stake.

Tomato cages may be made by using a 5 1/2 foot length of concrete reinforcing wire or pasture wire. The wire will form a circle 18 to 20 inches in diameter. The bottom horizontal ring of the wire cage should be cut off so that the ends can be pushed into the ground. After setting the cage in place over the tomato plant, drive 2 or 3 stakes




